

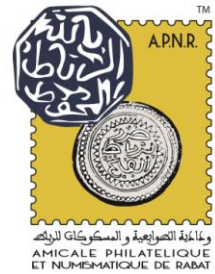


## 5<sup>th</sup> National Championship of Philately and numismatics-2019

### REGULATION OF THE THE 5th NATIONAL PHILATELIC AND NUMISMATIC CHAMPIONSHIP – PHILEXRABAT 2019 – 13/16 – 06 - 2019

#### **Article 1- Definition**

The 5th National Philatelic and Numismatic Championship - PHILEXRABAT 2019 is an annual event and cultural event aimed at gathering collectors around the same passion: philately and numismatics.

It is organized each year under the same theme: "memory and heritage".

It is competitive. The philatelic and numismatic collections exhibited are evaluated by a jury according to the general and specific regulations on international philatelic exhibitions, issued by the International Philatelic Federation (F.I.P.).

The valuation of numismatic collections is carried out by adapting the rules applied to philately.

#### **CHAPTER I – ORGANIZATION**

#### **Article 2 - Dates and place**

The 5th National Philatelic and Numismatic Championship - PHILEXRABAT 2019 will take place from 13 to 16 June 2019 at the Cultural Center of Agdal, located at Amir Abdelkader street, Agdal in Rabat.

#### **Article 3- Organizer**

PHILEXRABAT 2019 is organized by the Philatelic and Numismatic Association of Rabat (APNR), with the support of Poste Maroc and Bank Al Maghrib and in collaboration with the Agdal-Ryad District Council.

#### **Article 4 - Organizing Committee**

The Organizing Committee is composed of:

- President of the Show : President of the APNR;
- 1st Vice-President and President of the Jury Committee;
- 2nd Vice-President in Charge of Cultural Animation, SG of the APNR;
- Secretary General and Secretary of the Jury;
- An Assistant SG in charge of Logistics and Vice-Treasurer;
- Treasurer;

- A stock exchange manager;
- Moderator;
- Counselors;
- A Manager of Public Relations and Communication;
- Assistants of the Logistics Manager;

## **Article 5 - General theme**

PHILEXRABAT 2019 is organized under the theme: "Memory and Heritage".

## **Article 6 – Objectives**

The 5th National Philatelic and Numismatic Championship - PHILEXRABAT 2019 has for main objectives:

- Awareness on the conservation and protection of heritage, memory of a nation.
- The promotion of philately and numismatics and the dissemination of its cultural and educational values.
- The development of exchanges and friendly relations between philatelists and numismatists.
- To make known the development of the collection in all its aspects especially among the youth and the general public as well as the attraction which it represents with regard to leisures.

## **CHAPTER II - PHILATELIC AND NUMISMATIC EXHIBITIONS**

### **Article 7 - Exhibition classes**

At the 5th National Philatelic and Numismatic Championship - PHILEXRABAT 2019, all philatelic and numismatic collections that meet the following exposure classifications are admitted:

#### 7.1- Philately:

- Traditional philately;
- Postal history;
- postal stationary;
- Aerophilately;
- Thematic philately;
- Open Philately;
- Postcards ;
- Postmark;
- Erinophily;
- Literature;
- Youth;
- Event date stamps ... ..etc

#### 7.2- Numismatics:

- Traditional numismatics;
- Numismatic history;

- thematic numismatics;
- Open numismatics.

### 7.3- Other collections:

are admitted in this category all the collections not included in the paragraphs 7.1 and 7.2 (Philately and Numismatics). As for Numismatics, this category will be evaluated by adapting it to the Philately rules (Article 18).

### **Article 8 - Honorary class**

A class of honor, consisting of collections of all classes that have already won a medal or distinction in international or national exhibitions, will be opened as part of PHILEXRABAT 2019.

The latter are not subject to the assessment provided for in Article 18.

### **Article 9 - Standout Collections**

Any collections of members of the jury or collections not included in the exhibition classes listed in Article 7 and 8 will be closed. As a result, they are not subject to the jury assessment provided for in Article 18.

## **CHAPTER III – PARTICIPATIONS**

### **Article 10 – Participants**

The 5th National Philately and Numismatic Championship - PHILEXRABAT 2019 is open to any philatelist and numismatist who wishes to participate under the conditions of the present regulations. The participant can be affiliated or not with an association.

### **Article 11 - Entry form**

The entries must be completed and signed by the participants and sent to the Organizing Committee no later than April 30, 2019 by mail or email to the addresses indicated below:

A photocopy, in black and white or in color, of all the cards of the collection presented in competition must be attached to the entry form or sent to the Organizing Committee by April 30, 2019 at the latest.

Any collection must be, necessarily, the exclusive and complete property of the exhibitor who must be present, except fortuitous event or force majeure, throughout the duration of the exhibition.

Article 12 - Right and participation fee

Participation fees in competition classes are free.

The cost of transportation, lodging, catering and any other personal expenses are the responsibility of the participant.

### **Article 13 – Insurance**

The guarding of PHILEXRABAT 2019 is provided by the services of the Cultural Center of Agdal. However, participants will need to stay close to their collections to answer any questions visitors may have and to monitor their frames or shop windows during the day. All material risks of any kind (theft, fire, damage of any kind ...) remain the responsibility of the exhibitor. This one has the possibility:

- Or to remain his own insurer.
- Either personally and individually contract insurance from an insurance company of his choice.

## **CHAPTER IV - ATTRIBUTES OF PHILATELIC AND NUMISMATIC COLLECTIONS**

### **Article 14 - Allocation of frames and showcases**

For each collection displayed, it will be awarded from 1 to 3 frames or more than 16 A4 sheets each or 2 to 3 or more showcases, within the limit of available exhibition materials. The A3 horizontal format can be used (pay attention to the position in the frame). Collections awarded medals at international exhibitions and exhibited in honor classes will receive a number of appropriate frames or showcases.

#### **Article 15 - Presentation of collections**

Philatelic documents and banknotes to be exhibited must be presented on A4 or A3 (horizontal) sheets of light color, placed vertically in 16-leaf frames or 4 horizontal rows of 4 sheets (minimum 16 sheets for stamps and a minimum of 14 banknotes presented on 16 cards including 1 to 2 for the presentation).

The A3 horizontal format can be used (attention to the position in the frame).

The coins and related will be displayed in display cases, accompanied by an explanatory sheet for each piece, in addition to the cover page (minimum 14 coins on 16 cards including 1 to 2 for the presentation).

The leaves must be placed in a protective pouch of transparent material closed on three sides, the upper side must remain open.

Each sheet will be numbered top and right in order of presentation.

The cover page must include the following three elements:

- A brief title and in keeping with the development of the collection.
- An introduction that explains the content of the collection.
- A plan covering all the aspects that can be expected according to the title and the introduction.

All documents or exhibits must be originals. Photographs, photocopies, reproductions by any process (except the back of a coin with decisive postal marks), press clippings, postcards and all other non-philatelic or numismatic documents are only allowed for certain exhibition classes that provide for these types of documents or in rare cases. Works of art and jewels bearing the date and / or the city of the minting workshop are eligible for the numismatic contest, with the aim of encouraging the collection of heritage art objects.

The texts, written in the chosen language (Arabic, French and English), must provide additional information on elements and / or concordances. They must be written concisely, written legibly and without fail.

In the interest of the participant, a color photocopy of the collection must be made before the exhibition and kept by the exhibitor that he will give to the organizers at the opening of the show.

### **Article 16 - Assembly and dismantling of the exhibition**

The setting up of the collections will take place, for the philatelists, from 09 hours of the day of June 12, 2019 by the care of the participants. As for the numismatists, the editing will be done at 08 hours of the opening day of the show, Thursday, June 16, 2019. No document may be modified or removed, even momentarily, during the exhibition. Disassembly of the collections will be ensured by the participants at the end of the exhibition.

## **CHAPTER V - EVALUATIONS OF COLLECTIONS**

### **Article 17 - Jury and pupil-jury placement**

In view of the competitive nature of PHILEXRABAT 2019, the competing collections will be evaluated by a jury in order to determine the level of medal to be awarded to each exhibitor.

The juries, under the authority of the Vice-President of the APNR, are appointed by the Organizing Committee, in accordance with the provisions of the general regulations for international philatelic exhibitions.

As part of its training policy, the APNR will continue, at PHILEXRABAT 2019, the traineeship of jury-students which began during the 4th SNTM-Rabat 2018 for the benefit of philatelists and advanced numismatists.

Registrations will be registered by the Organizing Committee before March 31, 2019.

### **Article 18 - Judgment of collections**

The judgment of the collections takes into account exclusively what is exposed. No other object or document should be attached to or suspended from the frame.

The collections will be evaluated according to the general regulations of philatelic exhibitions of the International Philatelic Federation (FIP) and the provisions of the specific regulations of the various exhibition classes.

#### **Article 19 - Appraisals, observations and recommendations**

The Organizing Committee will make available to the members of the jury the categorical sheets of assessment, previously prepared. The jury is obliged to supplement them with observations and recommendations allowing the exhibitor to improve his collection.

A copy of these sheets will be given:

- To the exhibitor;
- To the organizing committee of the 5th National Philately and Numismatic Championship - PHILEXRABAT 2019;
- At the jury, at the request of the latter.

- The philatelic and numismatic passports of the exhibitors, previously completed with the place and the date of the exhibition.

In addition, the jury is responsible for initiating the jury-pupils enrolled in the evaluation of the collections.

## Article 20 - Classification of collections

The jury establishes an evaluation of the collections by assigning marks from 0 to 100, according to the scales specific to each class. Depending on the grade obtained, medal diplomas are awarded according to the table below.

national

- Great Or : 95/100 ;
- Or : 90/100 ;
- Great Vermeil : 85/100 ;
- Vermeil : 80/100 ;
- Great Silver : 75/100 ;
- Silver : 70/100 ;
- Silver Bronze : 65/100 ;
- Bronze : 60/100 ;
- Diploma : 50/100 ;



The deliberations of the jury are irrevocable and without appeal.

## Article 21 - Prizes and awards

Awards and prizes will be awarded in accordance with the decisions of the Organizing Committee, ie:

- Medals according to the obtained notes.
- Certificates of participation.
- Special awards offered by the sponsors to reward the collections in order of merit.

On the other hand, the 3 best stands will receive a medal (1 gold, 1 silver and 1 bronze), following an evaluation made by philatelist and numismatic visitors, by means of a card which will be given to them by the Jury President. the entrance to the room.

## CHAPTER VI - CULTURAL ACTIVITIES

### Article 22 – Conferences

Conferences will be hosted by experts at the CCA amphitheater.

Article 23 - Space for educational exhibition of materials

An exhibition space for philatelic and numismatic materials and products will be reserved for collectors who wish to present their collection techniques and methods.

### Article 24 - Training workshops

Philatelic and numismatic workshops are organized for the benefit of young people and beginners. They consist of practical introductory sessions on the collection of stamps,

philatelic documents and coins. The workshops are led by philatelists and skilled numismatists.

### **Article 25 - Philatelic and Numismatic Competitions**

Philatelic and numismatic competitions are held for the benefit of visitors in the form of quizzes, especially young people. The winners receive symbolic prizes in the form of philatelic and numismatic prizes.

### **Article 26 - Signing sessions**

Artists drawing stamps (subject to availability) or authors of books will animate autograph sessions.

## **CHAPTER VII - EXCHANGES SCHOLARSHIP**

### **Article 27 - Point of Sale of Poste Maroc**

In parallel with the exchange, it will be proposed to Post Morocco to install at the Salon a point of sale of philatelic products of recent years and to organize the launch of a special show that coincide with the holding of the Salon.

### **Article 28- Authorized Items**

In addition to stamps, vignettes, envelopes, postcards, coins, commemorative coins, medals, badges, pins, banknotes, stock titles, may also be exhibited: old cards, antique books, old paper, manuscripts, antique jewelery, watches, collections of works of art or all documents of historical, philatelic or numismatic interest. In summary, all products related to the stamp and the currency.

### **Article 29 - Exhibition stands**

Participants will be provided with a stand consisting of one or more tables.

### **Article 30 - Booking of stands**

Stand bookings will be opened now and closed by 31st March 2019, up to the maximum of the available tables, subject to the payment of a contribution towards the costs and the sending of the enclosed entry form. Exhibitors will be considered to be the persons whose entry form has regularly been sent to the organizers accompanied by the payment form.

### **Article 31 – Security**

The objects and documents on display remain the responsibility of their owners, at their own risk. The organizers can not be held responsible, especially in case of loss, theft or other damage, including fortuitous event or force majeure.



## **Article 32 - Plan of the hall**

The organizer establishes the event plan and distributes the locations. They will be awarded by a draw, separately, for each of the 3 categories: philately, numismatics and other collections,

## **Article 33 – Locations**

Outside the reserved spaces, it is forbidden to add personal tables in addition to those set up by the organizers.

It is strictly forbidden, for security reasons, to change the layout of the sites. The footage is fixed during registration and can not be modified.

Exchanges are prohibited outside the spaces provided for this purpose.

Street vendors are not allowed at the show.

## **Article 34 - Prohibited products**

No toxic or explosive products or similar dangerousness can be introduced in the lobby of the show. In the same way, no ideological, religious or political object affecting the national sacredness can be exposed.

## **Article 35: Cancellation of reservation**

For any cancellation of its reservation, the exhibitor will not be able to claim any refund after the date of March 31, 2019.

### Article 36 - Prohibitions

Smoking is not allowed in the lobby of the lounge. Animals are also forbidden for exhibitors and visitors.

## **Article 37 - Compliance with the rules of the fair**

The return of the signed entry form implies full acceptance of these rules.

## **CHAPTER VIII - MISCELLANEOUS PROVISIONS**

### **Article 38 – Catalog**

A catalog of the show will eventually be edited. Participant information will include the following:

- Identity: last name, first name, date of birth, occupation, telephone number, e-mail address.
- Collection: theme, title, class, medal diplomas obtained, dates and places. If it is a participant in the scholarship, he will mention his specialty.
- Association: name, function, date and place of incorporation.

Changes in information provided after final registration will not be considered.



## **Article 39 – Reservations**

This regulation is only valid for the event of the 5th National Philatelic and Numismatic Championship - PHILEXRABAT 2019.

The Organizing Committee reserves the right to make any changes to this regulation that it deems useful and will decide all unforeseen cases, in particular to refuse or exclude an exhibitor who disturbs the good order or the morality of the salon and this without compensation of any kind.

Participating in PHILEXRABAT 2019 implies the acceptance of all the clauses and conditions of this regulation.

## **Article 40 – Attire**

Proper attire for the duration of the Show.
